

**RESOLUTION NO. 26-R-03**

**A RESOLUTION AUTHORIZING ALEXANDER EQUIPMENT COMPANY, INC. TO PERFORM REFURBISHMENT SERVICES ON RM162 (2005 MORBARK MODEL 13) CHIPPER IN THE AMOUNT OF \$33,010.95**

**WHEREAS**, the City of Rolling Meadows (“City”) vehicle services division maintains the City’s vehicle and equipment fleet; and

**WHEREAS**, the City is a home-rule community, and the City Council may waive formal bidding procedures if it determines that such action is in the best interest of its residents; and

**WHEREAS**, Alexander Equipment Inc. is the only authorized distributor and service provider for Morbark equipment in Northern Illinois; and

**WHEREAS**, the City has a long-term capital program that includes replacing vehicles and equipment per the Vehicle Replacement Policy; and

**WHEREAS**, the City’s Vehicle Replacement Committee has reviewed and approved the recommendation to refurbish in lieu of replacing RM162; and

**WHEREAS**, Alexander Equipment Inc. has provided a quote to the City for a total cost of \$33,010.95 to refurbish RM162; and

**WHEREAS**, the Fiscal Year 2026 Vehicle and Equipment Replacement Budget provides funding in an amount of \$100,000 from account 25705025-60036.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE COUNCIL OF THE CITY OF ROLLING MEADOWS, ILLINOIS**, as follows;

**Section 1. Recitals.** The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

**Section 2. Approval.** The Mayor and City Council hereby authorize the City Manager to enter into agreements and other necessary documents with Alexander Equipment Inc. for the refurbishment of RM162 in the amount of \$33,010.95.

**Section 3. Waiver of Competitive Bidding.** To the extent any competitive bidding requirements apply to the agreements with Alexander Equipment Company, such competitive bidding requirements are hereby waived pursuant to section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).


**Section 4. Effective Date.** This Resolution shall be in full force and effect after its approval in the manner provided by law.


