

**RESOLUTION NO. 26-R-12**

**A RESOLUTION APPROVING AND AUTHORIZING AN EXTENSION AGREEMENT BETWEEN THE CITY OF ROLLING MEADOWS AND FLOOD BROTHERS DISPOSAL COMPANY FOR RESIDENTIAL CURBSIDE RECYCLING COLLECTION SERVICES**

**WHEREAS**, the City of Rolling Meadows (“City”) has entered into an agreement with Flood Brothers Disposal Company (“Flood Brothers”), dated June 23, 2021, for residential curbside recycling services within the City, which agreement is set to expire on June 22, 2026, at 11:59 p.m. (“Residential Recycling Agreement”); and

**WHEREAS**, the corporate authorities of the City have determined that it is desirable, necessary and in the best interests of the City to extend the terms of the Residential Recycling Agreement and approve an Extension Agreement between the City of Rolling Meadows and Flood Brothers Disposal Company, in order to continue the provision of residential curbside recycling collection services within the City, through September 22, 2026.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Rolling Meadows, Cook County, Illinois, as follows:

**Section 1:** The recitals set forth herein above are incorporated herein by specific reference as a part of this Resolution.

**Section 2:** The Extension Agreement attached hereto and incorporated herein as Exhibit A is hereby approved and the City Manager of the City of Rolling Meadows is hereby authorized to execute the Extension Agreement.

**Section 3:** To the extent any competitive bidding requirements apply to the Extension Agreement, the competitive bidding requirements are waived in accordance with Section 2-1133 of Article XI, of Chapter 2 of the Code of Ordinances, City of Rolling Meadows, Illinois.

**Section 4:** This Resolution shall be in full force and effect from and after its passage in the manner provided by law.



**EXTENSION AGREEMENT  
(City of Rolling Meadows Agreement to Provide  
Residential Curbside Recycling Collection Services)**

This Extension Agreement to the City of Rolling Meadows Agreement to Provide Residential Curbside Recycling Collection Services Agreement between the City of Rolling Meadows ("City") and Flood Brothers Disposal Company ("Contractor"), dated June 23, 2021 ("Residential Recycling Agreement"), extends the terms and conditions of the Residential Recycling Agreement.
