

**Resolution No. 22-R-45**

**A RESOLUTION TO AWARD A CONTRACT FOR FY2022 STREET RECONSTRUCTION PROJECT**

**WHEREAS**, in the opinion of a majority of the corporate authorities of the City of Rolling Meadows, Illinois (the "City") it is advisable, necessary and in the public interest that the City enter into a contract for the 2022 Street Reconstruction Project (the "Project"); and

**WHEREAS**, the City publically advertised for sealed bids for the Project and publicly opened, examined and declared six (6) bids from nine (9) potential contractors at 10:00 a.m., on April 12, 2022; and

**WHEREAS**, of the bids received and opened, the apparent lowest responsible bidder is ALamp Concrete Contractors, Inc., 1900 Wright Blvd., Schaumburg, IL, 60193; and

**WHEREAS**, the corporate authorities of the City hereby determine that it is in the best interest of the City to accept the proposal of ALamp Concrete Contractors, Inc. at the unit prices set forth within its proposal, and award the contract to ALamp Concrete Contractors, Inc. for the 2022 Street Reconstruction Project.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Rolling Meadows, Illinois, as follows:

**Section 1:** The facts and statements contained in the preamble clauses to this Resolution are found to be true and correct and are hereby adopted as part of this Resolution.

**Section 2:** The corporate authorities of the City hereby determine that ALamp Concrete Contractors, Inc. is the lowest responsible bidder for the Project.

**Section 3:** The proposal of ALamp Concrete Contractors, Inc., at the unit prices set forth within its proposal, in an amount not to exceed \$1,027,232.89, is hereby

accepted and the contract for the 2022 Street Reconstruction Project shall be awarded to ALamp Concrete Contractors, Inc.

**Section 4:** This project will reconstruct the following street segments:

- Plum Tree Lane
- Alder Court
- Croftwood Court
- Edgewood Court
- Green Meadow Court
- Heather Court
- Kimberry Court
- Mayberry Court

**Section 5:** Funding for the proposed street improvements is to be provided by MFT Funds (ReBuild Illinois Funds), Local Roads Fund (61), and Stormwater Fund (20).


